This lowered incidence of accumulations translated to virtually no periimplantitis. This is a major milestone for impantologists and their patients. A significant amount of time and energy has been spent among clinicians and clinical instructors (lecturers) speaking to the importance of how to manage peri implantitis cases. It would obviously be better to prevent the problem in the first case rather than

determining the best way manage it after the fact.


### **Additional Products**


